Councilman DeVitis read in the legislation and gave a brief overview of the discussion that took place during committees.

Councilman Speight gave a detailed overview of the discussion and public hearing that has been held up to this point. He went over the proposed changes to the ordinance.

Councilman Miller explained that he would be voting no, he feels that the community's opinion on this matters and that this is a drastic change that will create conflict between neighbors and doesn't feel like he can support it.

Councilman Neugebauer stated that 13 yrs ago they changed the ordinance to 2 acres, and it has not seemed to create issues thus far. He felt this new legislation was a good exercise and that treating everyone the same is the right thing, however the changes are too extreme and will vote no, as well.

Councilwoman Babbitt explained that she supports this legislation and is comfortable with the wording. Feels this is a good compromise. Doesn't necessarily agree with the consequence of a felony. Is concerned that the city has an identity crisis and has forgotten about its roots.

Councilman DeVitis stated that he agreed with Councilwoman Babbitt and the identity of Green. Through the collaborative efforts of council and the residents, they have come up with a good piece of legislation and compromise. Other communities that are similar to Green have even less strict rules on chicken rearing, or even none at all. He is happy that they have not added the HOA language and that the safeguards that have been written into the legislation will help this be successful. Americans in general are moving toward wanting to grow their own foods and know where their food is coming from, and this is a step in the right direction for that. It also respects Greens heritage and he will vote yes.
