A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO A LEASE AGREEMENT FOR THE PURCHASE OF ONE (1) 2020 DEMO JOHN DEERE 6500A E-CUT HYBRID FAIRWAY MOWER FOR USE AT THE RAINTREE GOLF AND EVENT CENTER, AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined that the City needs an additional mower for use at the Raintree Golf and Event Center to maintain its courses; and

WHEREAS, the City currently has an Agreement with Indigo Partners, formerly known as Billy Casper Golf LLC, to operate and manage Raintree Golf and Event Center; and

WHEREAS, the Service Director and Indigo Partners have jointly determined it is necessary to have an additional mower for use at the Raintree Country Club property to maintain the grounds at Raintree Golf and Event Center; and

WHEREAS, the new maintenance equipment will be purchased through Indigo Partners' vendor account for the best pricing to optimize savings.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SCTION ONE:

The Mayor is hereby authorized and directed to enter into a Lease Agreement through Billy Casper Golf, LLC, to purchase one (1) 2020 Demo John Deere 6500A E-Cut Hybrid Fairway Mower at a discounted price of Forty-One Thousand Nine Hundred Dollars (\$41,900.00) as a Least to Own Agreement, a copy of the quote summary is attached as Exhibit "A".

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the need for this equipment is immediate. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
