A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO A CONTRACT WITH MARKS CONSTRUCTION INC. FOR THE DEVELOPMENT OF RECTANGULAR ALL-PURPOSE YOUTH SPORT FIELDS, AND THE CONSTRUCTION OF ADA COMPLIANT WALKWAYS WITHIN ARISS PARK, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green desires to expand youth sport facilities, activities, and improve ADA accessibility within Ariss Park; and

WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on Thursday, February 17, 2022; and, Thursday, February 24, 2022 for the Ariss Park Improvements Project ("Project"); and

WHEREAS, on Wednesday, March 9, 2022, the City Engineer opened bids for the Project; and

WHEREAS, the City's contract requires bidders submit their bid guaranty and contract bond prior to the time and date of the bid opening; and

WHEREAS, Cavanaugh Building Corporation has been deemed unresponsive due to a failure to comply with all bid submittal requirements; and

WHEREAS, the City Engineer has reviewed the remaining bids and recommends the contract be awarded to Marks Construction Inc. as the lowest and best bidder for the Project in the amount of Three Hundred Eighty-Five Thousand Three Hundred Twenty-Nine Dollars and Eighty-Six Cents (\$385,329.86).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:
