Mr. Yeargin summarized Mr. Schmidt's explanation of the first two items on Exhibit A from the last meeting. Mr. Schmidt explained the first item was the Income Tax Fund. The City received three large tax payer refunds totaling just under \$308,000.00. There is a need for an additional appropriation within the income tax fund of \$250,000.00 to be able to refund additional taxpayers when they file their returns.

He advised the second item, the GO Bond Retirement Fund (General Obligation Bond Retirement Fund) as a result of the City entering into a new bond agreement, the first payment will be due in December this year. They City is asking for an additional appropriation out of the Bond Retirement Fund for a total of \$380,328.00 of that amount \$175,000.00 represents principle and \$205,328.00 represents interest. The total request in the supplemental appropriation measure is \$847,288.00. Mr. Yeargin asked how often the bond principle of \$175,000.00 will payment be required to be paid. Mr. Schmidt explained the bond payments are made annually on December 1 and the interest payments are made semi annually on June 1 and December 1. Mr. Yeargin said he has received calls from a few residents, they are seeing in the news that certain state and local budgets are being cut because of Covid - 19 and they want to know why the City is going forward on the construction on Massillon Road North. He wanted to explain that one of the primary reasons is because of the approximate \$15 million approved by Council almost 1/3 of that is coming from Federal Grants that will expire July 1 of this year. Bonds are at historically low rates and getting these bonds out now, our rates will probably be lower than if we wait. He also advised the city has a strategic reserve available. Time was requested and granted.

Mr. Pickett announced a revision. He first explained that they opened the bids on Friday and they were anxious to get this on the agenda because this funding is for 2020, which for O.D.O.T. ends June 30. He explained they needed this awarded and paper work to them by the beginning of June. They would like it passed at the second meeting in May. He explained that after they opened bids, they got an email from O.D.O.T. that the low bidder Cavanaugh Building Corporation had a slight error because they did not directly submit information to O.D.O.T. before or at the time of bid. They did include with the bid but not to O.D.O.T. and the Ohio Department of Transportation said the City is not allowed to award to them, they are to consider the bid unresponsive. He said they will amend for second reading to recommend the award to Spano Brothers who did submit the D.B.E. (Disadvantaged Business Enterprise). He explained, with Federal funded projects, they set a percentage for each project based on the region the project is going to take place in of work that has to be performed by subcontracts that are disadvantaged businesses. Mr. Yeargin asked what percentage of this project will be paid for with federal funds. Mr. Pickett said 80%. Mr. Yeargin clarified that roughly \$500,000.00 project that \$400,000.00 will be coming through a grant. Mrs. Babbitt asked the difference amount in the bids. Mr. DeVitis advised it was around a \$600.00 difference. Mr. Shaughnessy asked they get a legal opinion with regards to whether or not they have to do what O.D.O.T. says. He does not want the City to get caught up in mess down the road if they didn't look at a legal opinion. Mr. Pickett said they could certainly do that, the email from O.D.O.T. made it very clear that the City would not be allowed, per the rules, to use the Federal funding if we awarded to the bidder who did not provide that documentation. However, they did recommend that our legal council verify that we were comfortable with that. He said he did talk to Lisa Carey Dean about that and they have time to look at it before the next meeting. Mr. France asked Mr. Pickett to describe where the sidewalks would be going. Mr. Pickett explained it will connect Arlington Road, down Moore Road to Charleston. He said some portions are on both sides and others only one and he explained. Discussion continued about putting the trail through to East Liberty Park. Mr. Brandenburg said, looking at the City's budget, the City's portion is \$181,000.00 and the Federal Grant funding of \$500,000.00. The bid is \$511,000.00 He asked if they could expect further legislation or did it come in significantly cheaper than the estimate. Mr. Pickett said it came in significantly cheaper and he explained and they would only get 80% of the bid amount. He also explained they will be managing in house. Mr. Brandenburg asked if a 10-15% cushion was built in for overages. Mr. Pickett explained when they encumber the money with the award of the contract it will be added in then. Mr. Shaughnessy asked if there were many areas where a restraining wall would need to be built. Mr. Pickett said there would be none and he explained how they were able to do that. The Mayor said it was their intention to not use retention walls unless they have to.

X. Mayor's Report

Mayor Neugebauer talked about the Covid-19 Small Business Emergency Relief Grant Program done by Summit County. They had \$1.55 million to grant and they awarded all that to 300 businesses and 18 were in Green. Green did help fund part of that. From the Federal CARES Act they have realized they can allocated another \$5 million to that program. They will be making those grants available to more businesses in Summit County. They will be \$5,000 to eligible small businesses and they have widened the eligibility and he reviewed. They will also have for single person business grants. He said the \$50,000.00 that the city donated will be returned to the City by the end of the year because of the CARES Act. He also talked about the Green Together Food Drive. They collected over 10,000 food items in the first week and have three more days this week. He said there have been over 2,900 mask collected and residents can request masks and explained how. The Mayor explained a video that will be released and virtual events that will be done since the regular Memorial Day activities will not be happening. He also announced a Mind Mixer that will be done virtually to share thoughts and opinions on the Green Parks Master Plan.
