A RESOLUTION CONFIRMING ESTABLISHED PAY RANGES FOR THE SEASONAL POSITIONS OF SEASONAL LABORER I, SEASONAL LABORER II, AND SEASONAL RECREATION AIDE, AND REQUESTING FLEXIBILITY FOR DETERMINING SEASONAL PAY RATES WITHIN THESE RANGES BASED ON PREDETERMINED SKILLS, EXPERIENCE AND EDUCATION CRITERIA, AND DECLARING AN EMERGENCY.

WHEREAS, part-time temporary seasonal positions within the City of Green are unclassified and non-bargaining; and

WHEREAS, the City previously established a pay range for Seasonal Laborer I and Seasonal Laborer II by Resolution 2016-R11; and, also previously established a pay range for Seasonal Recreation Aid by Resolution 2017-R09; and

WHEREAS, Resolution 2017-R09 imposed limitations on the City's ability to recognize related education and experience and included requirements that are unnecessary for the Seasonal Recreation Aide, i.e. various certifications; and

WHEREAS, the City recognizes the efficiency of merging Seasonal Laborer I wage rates with Seasonal Recreation Staff, leaving the Seasonal Laborer II, with CDL qualifications separate; and

WHEREAS, the City does not request an increase in the pay ranges already established but seeks the flexibility to incentivize all returning Seasonal Applicants possessing the skills and experience needed to perform seasonal duties throughout the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

SECTION ONE:

Green City Council approves the pay range below for the Seasonal Laborer I, Seasonal Laborer II, and the Seasonal Recreation Aide. All seasonal pay ranges are applied in consideration of prior experience and relevant education as determined by the City Administration and monitored by the Human Resource Department.
