A RESOLUTION CREATING THE PART-TIME, NON-BARGAINING POSITION OF OUTREACH ASSOCIATE, ESTABLISHING A PAY RANGE FOR THE NEWLY CREATED POSITION, ESTABLISHING THE POSITION AS A NON-EXEMPT AND NON-CLASSIFIED UNDER THE CIVIL SERVICE RULES AND REGULATIONS; AND DECLARING AN EMERGENCY.

WHEREAS, the City recognizes the need to manage the growing number of mental health related needs in the community and the limited resources to aid in these situations; and

WHEREAS, to accomplish these activities in the most effective and efficient manner, the knowledge and skills required are best delivered by a certified nurse, paramedic, licensed counselor or licensed social worker with a background in mental health; and

WHEREAS, the Administration deems it necessary to create the position of Outreach Associate to supplement the Fire Division's current resources; and

WHEREAS, the City desires to establish a rate of compensation for the position of Outreach Associate; and

WHEREAS, it is necessary to determine the classification of the position under the Civil Service Rules and Regulations.

WHEREAS, first reading passage is requested to meet the timeline for acceptance of the grant, advertising and filling the position for a January 1, 2025, start date.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council establishes the position of Outreach Associate with the job description as set forth in Exhibit A. The position of Outreach Associate is established as a Pay Grade 8, part-time position (average 20 hours per week) at hourly rate of \$27.30 to \$40.95.

SECTION TWO:

The position of Outreach Associate shall be FLSA non-exempt and a non-classified position under Civil Service Rules and Regulations.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that this is an appropriation of money. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
