A RESOLUTION MAKING AN ADDITIONAL APPROPRIATION OF SEVENTEEN THOUSAND THREE HUNDRED FORTY DOLLARS AND THIRTY-ONE CENTS (\$17,340.31) IN THE PLANNING CONSULTANTS/CITY ENGINEER ACCOUNT FOR ENGINEERING SERVICES PROVIDED BY ENVIRONMENTAL DESIGN GROUP ("EDG") AND AUTHORIZING THE PAYMENT OF PAST DUE INVOICES FOR ENGINEERING SERVICES, AND DECLARING AN EMERGENCY.

WHEREAS, the Planning Director determined additional funds are necessary for the past due invoices for engineering services ordered and received in 2020; and

WHEREAS, it has been determined the City of Green has contracted and received engineering services and that exceed the 2020 appropriations at year-end; and

WHEREAS, Ohio Revised Code Section 5705.41 requires Green City Council to authorize expenditures that exceed appropriations at the time of expenditure.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

SECTION ONE:

Green City Council approves the appropriation of Seventeen Thousand Three Hundred Forty Dollars and Thirty-One Cents (\$17,340.31) to the Consultants/City Engineering Account (Acct# 247-5200-52412) for contracted engineering services from the unappropriated balance of the Planning Fund. Green City Council further authorizes the Finance Director to make payment to Environmental Design Group for the consulting engineering services. The Finance Director is authorized to make payments for these services through the established purchase order procedure.

SECTION TWO:

Green City Council authorizes the payment of all invoices for contracted engineering services ordered and received to date that exceed the original appropriation levels.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green and for the further reason that this is an appropriation of money. Provided that this legislation receives the affirmative vote

of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
