A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO AN AGREEMENT WITH GUIDE STUDIO, INC. FOR THE SYSTEMWIDE WAYFINDING SIGNS PROJECT, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City desires to enter into a professional services agreement with Guide Studio, Inc. to develop and design standard identification and wayfinding signage for the parks system; and

WHEREAS, the Service Department issued a Request for Qualifications to five (5) firms receiving statement of qualifications from two (2) firms; and,

WHEREAS, the project team reviewed each statement of qualification and determined Guide Studio, Inc. as being the most qualified firm; and

WHEREAS, Green City Council has appropriated for the parks 2022 capital projects program Twenty Thousand Dollars (\$20,000) from the Parks Capital Projects Funds (2021 R77 A) into The System Wide Wayfinding Signs Project (Acct. #402-6000-53622) for this project; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into an agreement between the City of Green and Guide Studio, Inc. per their proposal which is attached hereto and incorporated herein as Exhibit "A".

SECTION TWO:

Green City Council authorizes the Finance Director to make payment to Guide Studio, Inc. for this project through the established purchase order process.

SECTION THREE:

The Finance Director is authorized to appropriate the sum of Nine Thousand Dollars (\$9,000.00) System Wide Wayfinding Signs Project (Acct. #402-6000-53622) from the unappropriated balance of the Parks Capital Projects Fund for a total project cost of Twenty-Nine Thousand Dollars (\$29,000.00).

SECTION FOUR:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FIVE:

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the need for this material is immediate. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
