INTRODUCED: FEBRUARY 26, 2019 ASSIGNED TO:

A RESOLUTION DONATING REAL ESTATE OWNED BY THE CITY OF GREEN TO SUMMIT COUNTY LAND REUTILIZATION CORPORATION FOR THE PURPOSE OF DEMOLITION OF THE STRUCTURES ON THE PROPERTY AND ACCEPTING THE LAND FROM THE SUMMIT COUNTY LAND REUTILIZATION CORPORATION TO THE CITY OF GREEN UPON COMPLETION OF THE DEMOLITION, AND DECLARING AN EMERGENCY.

WHEREAS, the Summit County Land Reutilization Corporation has a program under the Ohio Housing Finance Agency ("OHFA") Neighborhood Initiative Program to fund the demolition of structures; and

WHEREAS, the City of Green accepted the donation of property located at 6423 S. Main Street for the future purpose of a park and open space lands; and

WHEREAS, the parcel of land has a home and outbuilding with no value and no need to maintain.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the donation of the land located at 6423 South Main Street to the Summit County Land Reutilization Corporation and upon the completion of the demolition of certain structures on the property, returning the land back to the City of Green for the original purpose of park and open space lands. Said Project to be done in accordance with the Real Estate Donation Agreement, a copy of which is attached hereto and incorporated herein as Exhibit "A".

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
