A RESOLUTION AWARDING A CONTRACT TO INTERSPIRO, INC. FOR THE PURCHASE OF FORTY-FOUR (44) SELF-CONTAINED BREATHING APPARATUS'S AND ACCESSORIES, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, Resolution 2017-R40 accepted the Fiscal Year 2016 Assistance to Firefighters Grant ("Grant") for the purchase of replacement self-contained breathing apparatus ("SCBA") equipment; and

WHEREAS, the City of Green has been awarded the Grant in the total amount of \$240,614.00; and

WHEREAS, the matching local share is ten percent (10%); and

WHEREAS, the City of Green advertised a "Notice to Bidders" in The Suburbanite on Friday, May 18, 2018; and, Friday, May 25, 2018, for the Self-Contained Breathing Apparatus for the Fire Department; and

WHEREAS, on Friday, June 8, 2018, the Fire Chief opened bids for the Project; and

WHEREAS, the Fire Chief has reviewed the bids and recommends the contract be awarded to Interspiro, Inc. as the lowest and most responsive and responsible bidder for the Project in the amount of \$264,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

The City received and opened the following bids on June 8, 2018:

SECTION TWO:

City Council finds, based on all relevant factors, that Interspiro, Inc. with its total base bid of \$264,000.00, is the lowest most responsive and responsible bidder for the Project and agrees to comply with all specifications.

SECTION THREE:

The Mayor is authorized and directed to enter into an Contract with Interspiro, Inc. for the purchase of forty-four (44) self-contained breathing apparatus's and accessories for the Fire Department. and make payments to Interspiro, Inc. through the established purchase order procedures.

SECTION FOUR:

The Finance Director is authorized to appropriate the total sum of Two Thousand Four Hundred Dollars (\$2,400.00) to the SCBA Self Contained Breathing Apparatus account (Acct# 210-3300-53645) from the unappropriated balance of the Fire/Paramedic Fund.

SECTION FIVE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION SIX:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths ($\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
