

GREEN CIVIL SERVICE COMMISSION MEETING MINUTES FEBRUARY 12, 2020

Mr. Robert Calderone called the meeting to order at 6:00pm and noted Mrs. Kimberly Baer was present. Also present was Pam Serina and Melinda Svenson from Human Resources. Mr. Clark Westfall called in via telephone.

MINUTES

Commission reviewed the January 8, 2020 meeting minutes. Mrs. Baer made a motion to approve and Mr. Calderone seconded the motion.

CORRESPONDENCE

- Commission reviewed the expense report ending January 31, 2020. Melinda informed the Commission we have not spent any monies out of these funds year to date. Mr. Westfall asked if the funds requested for 2020 were standard for the Commission from past years and the Mrs. Baer and Mr. Calderone confirmed this to be true. Pam stated there should be no reason to ask for additional funds in 2020 based on the staffing needs we knew of as the end of 2019.
- Commission discussed and extended the following staffing requisition:
 - o Fire Medic for eight openings
 - Pam informed the Commission that seven candidates are in the final stages of being processed for appointment. Pam stated three have finished completely and four are in the final steps. Pam stated all information on the initial seven should be in by the week of February 17, 2020. Pam informed the Commission there was one candidate who is lagging behind due to being an alternate to an original candidate who did not make it through the initial testing phase.
 - Commission agreed to extend this requisition until April 15, 2020. Mr. Calderone made a motion to extend this requisition and Mrs. Baer seconded the motion. Requisition was initially signed by the Commission November 25, 2019. Pursuant to CSC Rule 7.1, Commission can extend the requisition past the initial 60 days. The Fire Medic requisition will now expire April 15, 2020.
- Commission reviewed the following staffing requisition:
 - o Traffic Control Tech II for two openings.
 - Commission reviewed the requisition and Mr. Calderone signed the requisition, checking the box for "Commission Reviewed/No Action Required". (Position is an AFSCME position which is anticipated to be filled from the bargaining unit.)
- Commission reviewed and singed the following Payroll Status Forms:
 - o Nicholas Thompson, Service Worker II (New Hire Storm Water)
 - o Michael Props, Service Worker II (New Hire Storm Water)
