**A RESOLUTION AMENDING VARIOUS GREEN CITY COUNCIL RULES OF PROCEDURE, AND DECLARING AN EMERGENCY.**

WHEREAS, City Council endeavors to run efficient, professional meetings in the name of public transparency; and

WHEREAS, City Council's Rules of Procedure have not been substantially updated for many years; and

WHEREAS, many members of Green City Council have expressed a desire to amend, change and add rules to more effectively and efficiently run the City's legislative body.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:**

**SECTION ONE:**

Green City Council Rules of Procedure shall be revised and amended to read as more fully set forth in Exhibit "A", a copy of which is attached hereto and incorporated herein by reference.

**SECTION TWO:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

**SECTION THREE:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and so that the new rules may be implemented as soon as possible. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
