A RESOLUTION AMENDING RESOLUTION 2017-R24 PASSED BY COUNCIL ON OR ABOUT APRIL 11, 2017 TO RECLASSIFY THE DONATION AS A PAYMENT TO THE 501(C)(3) NON-PROFIT ORGANIZATION, COALITION TO REROUTE NEXUS, IN THE AMOUNT OF TEN THOUSAND DOLLARS (\$10,000.00), TO ASSIST WITH LEGAL SERVICES, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green wished to grant restricted funds to the Coalition to Reroute NEXUS to be used for legal services rendered to oppose the location of the NEXUS Pipeline in the City; and

WHEREAS, the City of Green has formally opposed the current route of the NEXUS Pipeline through the City of Green, and continues to strongly encourage NEXUS to utilize the alternate route provided by the City of Green Planning Department; and

WHEREAS, the City of Green formally supports the Coalition to Reroute NEXUS and its efforts to legally oppose the NEXUS Pipeline route through the City of Green; and

WHEREAS, at this time, it has become necessary to reclassify the donation as a payment.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

City Council amends Resolution 2017-R24 to reclassify the donation as a payment. All of the rest of the Resolution not specifically amended herein shall remain in full force and effect.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that it can be effective immediately. Provided that this legislation receives the affirmative vote of three-fourths (¾ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
