A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO AN AGREEMENT WITH A MANAGEMENT COMPANY TO ACCEPT THE PROPOSED BID PURSUANT TO THE REQUEST FOR PROPOSAL FOR RAINTREE COUNTRY CLUB, INC. AND RAINTREE GOLF, LLC., AND DECLARING AN EMERGENCY.

WHEREAS, the Administration has reviewed several Request For Proposals ("RFP") from management companies that wish to enter into a contract with the City of Green regarding Raintree Country Club, Inc., and Raintree Golf, LLC.; and

WHEREAS, the Administration believes it to be in the best interest of the City to enter into an Agreement with a management company to accept the proposed bid pursuant to the RFP.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

## **SECTION ONE:**

Green City Council authorizes the Mayor to enter into an Agreement with a management company to accept the proposed bid pursuant to the request for proposal regarding Raintree Country Club, Inc. and Raintree Golf, LLC.

## **SECTION TWO:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings if this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

## **SECTION THREE:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
