**A RESOLUTION APPROVING AND ADOPTING THE 2019 ANNUAL CAPITAL APPROPRIATIONS FOR THE CITY OF GREEN, MAKING TRANSFERS, AND DECLARING AN EMERGENCY.**

WHEREAS, pursuant to the general laws of the State of Ohio, it is necessary to adopt a Capital Appropriation Resolution for the operation of the City of Green for fiscal year 2019.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:**

**SECTION ONE:**

Green City Council approves and adopts the 2019 Capital Appropriations for the City of Green, a copy of which is attached hereto and incorporated herein as **AMENDED** Exhibit "A".

**SECTION TWO:**

*Green City Council approves the transfer of One Hundred Twenty-Five Thousand Dollars (\$125,000.00) from the General Fund to the Capital Projects Reserve Fund, to provide the necessary cash flow to purchase land for Fire Station #3.*

**SECTION THREE:**

*Green City Council approves the transfer of One Million Dollars (\$1,000,000.00) from the General Fund to the Street Construction, Maintenance and Repair Fund to provide for additional resurfacing of roads.*

**SECTION TWO FOUR:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action were in meetings open to the public, in compliance with all legal requirements.

**SECTION ~~THREE~~ FIVE:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green and for the further reason that the Project is set to proceed immediately. Provided that this legislation receives the affirmative vote of three-fourths ( $\frac{3}{4}$ ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
