ASSIGNED TO:

A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO A CONTRACT WITH BL COMPANIES, INC. FOR PROFESSIONAL ENGINEERING SERVICES FOR THE RABER ROAD SIDEWALK AND MULTI-USE TRAIL PROJECT, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, Resolutions 2018-R16 and 2019-R108, Green City Council approved Contracts ("Contract") with BL Companies, Inc., for Professional Engineering Services for the Raber Road Multi-Use Trail Project ("Project"); and

WHEREAS, over the past few years, the City of Green has budgeted and expended a total of One Hundred Thirty-Seven Thousand Six Hundred Dollars (\$137,600.00) with BL Companies on Phase I & II designs, with relocated roadway allowing the City to cover through Stage 2 of the design submittals; and

WHEREAS, in March of 2021 BL Companies Inc. provided a final design proposal including Stage 3 design submittals, Stormwater Pollution Prevention Plan development ("SWPPP Plan"), bidding and construction phase services; and

WHEREAS, the City of Green has been working closely with BL Companies, Inc., and the Ohio Department of Transportation to plan the Raber Road Sidewalk Project; and

WHEREAS, the City desires an approval of the Contract with BL Companies, Inc., for Professional Engineering Services for Phase Three & Final Design and construction documents, SWPPP Plan Preparation, and additional engineering services during the bidding and construction phases; and, desiring a Contract in the amount of Forty-Eight Thousand Four Hundred Dollars (\$48,400.00); and

WHEREAS, it is necessary for Green City Council to approve this Contract to complete the scope of work.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Mayor to enter into the Contract, a copy of which is attached hereto and incorporated herein as Exhibit "A", for stage three and final design, as well as engineering services during the bidding and construction phase.

SECTION TWO:

Green City Council authorizes the appropriation of Forty-Eight Thousand Four Hundred Dollars (\$48,400.00) to the Raber Road Sidewalk Account (Account #201-2100-53643), from the unappropriated balance of the Street Construction, Maintenance and Repair Fund, to provide sufficient funding for the professional engineering services. Green City Council further authorizes the Finance Director to make payments through the established purchase order procedure.
