# A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO AN AGREEMENT WITH ENVIROSCAPES FOR THE CONSTRUCTION AND INSTALLATION OF THE CENTRAL PARK IDENTIFICATION SIGN, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green desires to install a Central Park Identification Sign at the Central Park Steese Road parking lot entrance; and

WHEREAS, the Service Department issued a Request for Proposal ("RFP") to six (6) companies to provide cost estimates for the construction and installation of the identification sign; and

WHEREAS, the City received two (2) Request for Proposal Quotes for the Project; and

WHEREAS, the City Service Director has reviewed the Request for Proposal Quotes and recommends and determined the Agreement be awarded to Enviroscapes as the lowest and best for the Project, a copy of which is attached hereto and incorporated herein as Exhibit "A"; and

WHEREAS, the City of Green Parks and Recreation Board supports and recommends the expenditure of parks capital funds for the construction and installation of the Central Park Identification Sign at the Central Park Steese Road parking lot entrance; and

WHEREAS, it is necessary to appropriate the funds to pay for the construction and installation of the Central Park Identification Sign to complete this Project.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

## **SECTION ONE:**

Green City Council finds, based on all relevant factors, that Enviroscapes, with its total of Forty-Six Thousand Nine-Hundred Forty-One Dollars and Forty-Eight Cents (\$46,941.48), is the lowest and best bidder for the Project and agrees to comply with all specifications.

## **SECTION TWO:**

The Mayor is hereby authorized and directed to enter into an Agreement with Enviroscapes for the Project. The Finance Director is authorized to make payment to Enviroscapes through the established purchase order procedure.

### **SECTION THREE:**

The Finance Director is authorized to appropriate the sum of Forty-Six Thousand Nine Hundred Forty-One Dollars and Forty-Eight Cents (\$46,941.48) to the Central Park Sign Account (Acct #402-7115-53631) from the unappropriated balance of the Parks Capital Projects Fund.

## **SECTION FOUR:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

#### **SECTION FIVE:**

Green City Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green and for the further reason that this is an appropriation of money. Provided that this legislation receives the affirmative vote of three-fourths (<sup>3</sup>/<sub>4</sub>ths) of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
