A RESOLUTION AUTHORIZING THE CITY OF GREEN TO ENTER INTO AN AGREEMENT WITH FINN CORPORATION FOR THE PURCHASE OF A FINN MULCH BLOWER, MAKING AN APPROPRIATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green has determined the need for a professional grade mulch blower; and

WHEREAS, the City of Green Parks Capital process supported the need for a mulch blower; and

WHEREAS, the City of Green Parks and Recreation Board supports and recommends the expenditure of parks capital funds for the purchase of this mulch blower; and

WHEREAS, it is necessary to appropriate the funds to pay for new equipment.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

#### **SECTION ONE:**

Green City Council authorized the purchase of a professional grade mulch blower from FINN Corporation through the Cooperative Purchasing Program in amount of One Hundred Seven Thousand Two Hundred Twenty-Eight Dollars and Fifty-Five Cents (\$107,228.55), as attached hereto as Exhibit "A".

# **SECTION TWO:**

The requirement of competitive bidding is waived pursuant to Section 210.05 of the Codified Ordinances of the City of Green. This purchase is in accordance with the National Joint Powers Alliance ("NJPA") Contract #052417-FINN, a copy of which is attached hereto as Exhibit "B".

# **SECTION THREE:**

The Mayor is hereby authorized and directed to enter into an Agreement with Finn Corporation for the purchase of a FINN MB50 Material Blower. The Finance Director is authorized to make payment to the Finn Corporation through the established purchase order process.

#### **SECTION FOUR:**

The Finance Director is authorized to appropriate the sum of Forty-Three Thousand Two Hundred Twenty-Eight Dollars and Fifty-Five Cents (\$43,228.55) to the Equipment Account (Acct #402-6000-53640) from the unappropriated balance of the Parks Capital Projects Fund.

# **SECTION FIVE:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.
