Mr. Shaughnessy opened the public hearing at 7:22 p.m. He read in the title.

Brenda Fargo started by apologizing for the public hearing. She explained the aggregation program and why the City is allowed to do that. Charlie Reimer was also here to answer questions. Mr. Shaughnessy asked her to explain the aggregation process. Mr. France asked for some of the benefits of joining. Mrs. Fargo explained the grant program and the Do Not Knock program. Mrs. Wax Carr talked about the information that was shared today. Mr. Shaughnessy asked how this worked for the citizens. Mrs. Fargo said all eligible customers will get an opt out letter and they will have 21 days to review the program. The will have to mail in an opt out card if they do not want to go on the program. Mrs. Fargo said there are over 200 communities that have joined. Including Summit County for all the townships, Norton, Macedonia and Lakemore. The Mayor asked if it will say NOPEC on the bill. Mrs. Fargo said it will. There was discussion on if it could be adopted tonight. She suggested that everyone look at their gas bill and see what their rate is. There was discussion about joining aggregation programs.

Robert Telenda 2740 Compass Point Drive - He asked if Council had all the information they needed to answer questions. Mrs. Wax Carr said she would be happy to take calls. Mrs. Fargo said they work with the communities on onboarding to explain everything. She suggested if they get calls to tell those to call the 1-800 number on their bill. If Council does not vote for this, the residents would go back on the utility in April. She explained her company and how they work with communities with aggregation.

He reappointed to Parks and Recreation Board Jennifer Foster for another five year term. To fill the vacant seat of Mr. Chojnacki's the Mayor appointed Victor Pinheiro. He will fill Mr. Chojnacki's term until December 31, 2022. To the Audit Committee he appointed Robert Talenda to fill the vacant seat that Mr. Brandenburg left when he was elected to Council. To the Living Green Task Force he reappointed

Joel Engman and Nicholas Roth for a four year term each.
